This session will provide a brief overview of OSHA reportability verses recordability and the requirements of both according to OSHA. The primary emphasis of this short, practical session, however, will be on how to complete OSHA Form 300A: Summary of Work-related Injuries and Illnesses Report. This form is required to be completed by certain employers and posted annually from February 1 – April 30. This quick refresher session will help you understand the key requirements for completing the OSHA form 300, 300A, the posting deadlines, and the electronic filing requirements. Expect a practical, how-to session that is shorter than our normal session.

So, if you are looking for an area to impact your organization's losses or you simply want to make your workplace safer for your newest employees, this session will provide plenty of ideas to consider that may work well in your organization. This session dives deeper into a fresh perspective on the process of investigations, contributing factors of human error and the impact on the safety culture.

Examining Slips, Trips and Falls in General Industry –The Second Leading Injury Type for Most Organizations

The second leading workers' compensation claim for most industries will typically be a slip, trip or fall (STF). These occurrences were also the costliest claim type in PMA Companies' recent study on severe events in the workplace – discussed in session. To help your organization strengthen your controls in this area, we will lay out steps you can take to effectively assess the STF risks of your operation. This will help create an awareness of this injury type for your organization that will help set the stage for selecting and implementing controls that may be needed to help your organization see significant reductions in these incidents. Expect discussions on leadership and management to be included in this area along with resources and references that can help you target your organization's specific areas of concern.

Examining Slips, Trips and Falls in Healthcare with an Emphasis on Approaches That

Can Reduce Incidents

Slip, trip and fall claims in the healthcare setting are usually the first or second most common loss type for the organization from a workers' compensation perspective. As a result, slip, trip and fall claims affect daily operations such as staffing, short and long-term costs (employee and workers' compensation) and can even place strains on hiring and retention in the organization. In this session we will talk about causes of falls in healthcare, how you can assess this risk in your organization and implement effective strategies for reducing slip and falls, including the roles of leadership and employees.
